POSI-PLUS AERIAL LIFT WARRANTY



This warranty applies only to the initial owner of the unit.

A. DURATION

All products manufactured and installed by Posi-Plus Technologies Inc. bear a twelve (12) month warranty period, called INITIAL WARRANTY PERIOD, from the inservice date. The delivery date is considered to be the in-service date unless the owner specifies a different in-service date when returning to Posi-Plus Technologies Inc. **Attachment** of this document. The new in-service date must be within six (6) months of the delivery date.

This WARRANTY is EXTENDED to all major structural components manufactured by Posi-Plus Technologies Inc. for as long as the original owner owns the aerial lift

B. COVERAGE

Parts and Labor

The warranty outlined in paragraph "A" will cover defects in workmanship as well as all materials incorporated into products manufactured by Posi-Plus Technologies Inc. The warranty includes the cost to replace or repair the part(s) for the period of the warranty.

Delivery charges

The delivery charges to the owner or the Service Centre location of the defective and replacement or repaired parts will be assumed by Posi-Plus Technologies Inc. for the first three (3) months.

Unit Transportation charges

The unit transportation charges to the designated Service Centre or the traveling time of the Road Service unit will be assumed by the manufacturer for the first three (3) months.

Replacement Parts

The parts manufactured by Posi-Plus Technologies Inc. will be replaced by new or refurbished components and the warranty of the replaced components will be limited to the initial warranty period of the aerial lift. Replacement parts supplied by Posi-Plus Technologies Inc. after the INITIAL WARRANTY PERIOD will bear a three (3) month warranty.

The EXTENDED WARRANTY will cover O.E.M steel components which were originally manufactured at the initial in-service date: Insert and outrigger weldments, sub-frame, pedestal, turntable, hydraulic cylinder structures, and scissors. Wear components, such as bushings, pads, seals and gaskets, are excluded. The EXTENDED WARRANTY will cover the material and the labor only. The Unit transportation charges will be assumed by the owner of the unit

C. WARRANTY LIMITS

- 1- Assembly and installation of products manufactured and sold by Posi-Plus Technologies Inc. must be performed in accordance with the standards prescribed by the company. These standards are available from the company upon request by the owner.
- 2- This warranty applies only to replacement of defective parts as well as labor by personnel of Posi-Plus Technologies Inc. or Authorized Service Centre, with the replacement parts and labor performed expressly agreed upon in advance.
- 3- During the period between the date of delivery and the in-service date, the owner must maintain the equipment in good condition in accordance with standards set by Posi-Plus Technologies Inc. and supplied at time of delivery of said equipment in the maintenance manuals.
- 4- Posi-Plus Technologies Inc. reserves the right to improve its aerial lifts without obligation to modify aerial lifts already in service.
- 5- Posi-Plus Technologies Inc meets or exceeds the standards described in the CSA C225-10 and/or the ANSI A92.2-2015 Standards, whichever is applicable.

IF THE OWNER DOES NOT CARRY OUT THE REQUIRED SPECIFIED MAINTENANCE & INSPECTIONS, THIS WARRANTY WILL BE NULL AND VOID.

D. EXCLUSIONS

- 1- No reimbursement or allowance will be granted for any work and/or a repair performed by persons, or companies other than Posi-Plus Technologies Inc., or Authorized Service Centers.
- 2- Any claims for other loss or damages of any type (including, but not limited to, loss from failure of the product to operate or perform for any period of time, other economic or moral loss, or direct, immediate, special, indirect, incidental or consequential damage) are expressly excluded herein.
- 3- This warranty does not cover damage resulting from misuse, negligence, accident or operation which is not in strict compliance with standards set out by Posi-Plus Technologies Inc. in the Operator's and Maintenance manuals and/or by exceeding specified capacity limits. It is the owner's responsibility to abide by the CSA C225-10 and/or the ANSI A92.2-2015 Standards in regards to the operation, use and maintenance of the aerial lift.
- 4- This warranty will become null and void if one or more original adjustment seals are removed from the hydraulic valves.
- This warranty is null and void if the equipment is not operated and/or maintained in accordance with standards set by Posi-Plus Technologies Inc. in the operation and maintenance manuals and with the CSA C225-10 and/or the ANSI 92.2-2015 Standards. The checklist for the Preventative Maintenance Program is included in the maintenance manual for each unit. The completion of these documents by an authorized mechanic or an authorized service centre will be used as proof of appropriate maintenance.
- 6- This limited warranty is in lieu of any other warranties, express or implied, including, but not limited to, any warranty of merchantability or fitness for a particular purpose.

Written authorization must be obtained from Posi-Plus Technologies, prior to proceeding with any work under a warranty claim. An official form must be completed by the owner. This form can be obtained by contacting the Customer Service Department and is included in the maintenance Manual delivered with the unit.
